



GENERAL RULES AND REGULATIONS

FLORIDA STATE SALES TAX: All vendors are responsible for collection and payment of Florida State Sales tax.

PLANT CONDITION: All plant vendors agree to provide only strong disease-free products to their patrons. The Show Committee reserves the right to insist on removal of visibly diseased plants from exhibits and/or sales areas. Failure of the exhibitor or vendor to comply with a directive for plant removal will result in action by the Show Committee to effect compliance and could result in removal of their entire display or sales area with forfeiture of lease and related payments.

PRODUCT LIABILITY: Vendors assume all product liability and hold harmless 19WOC, Inc. as well as its officers, directors, and committee persons from all claims regarding product liability.

MARKING OF SALES ITEMS: Vendors agree to mark all items sold to Show patrons in the manner directed by the Show Committee.

CARE OF EXHIBIT SPACE: Exhibitors agree to maintain their display space in order to present the best possible appearance throughout the show. Wilted or dead flowers will be promptly removed or replaced. Exhibitors may not dismantle any part of their displays before the official closing of the Show.

SUB-LEASING OF SPACE: Exhibitors/Vendors may not assign, sublet or apportion the whole or any part of the booth space assigned or permit any other party to exhibit therein. Exhibitors may not distribute any promotional or advertising materials in the occupied space, other than those concerning products manufactured, grown, or normally sold in the regular course of business.

SECURITY: 19WOC will provide adequate security service for the exhibit hall during the hours of the Show, as well as when the Show is closed. As further protection, 19WOC management encourages each exhibitor to have at least one employee in his/her booth during the hours of move-in and particularly during the hours of move-out, so that each exhibitor will assist in the security of his individual materials. 19WOC management also encourages that the exhibit booths be manned at all times during regular Show hours by qualified regular employees of the exhibitor. However, in all cases, the **ULTIMATE RESPONSIBILITY OF SECURITY LIES WITH THE EXHIBITOR AT ALL TIMES AND 19WOC WILL NOT BE HELD LIABLE FOR THE LOSS OR THEFT OF ANY OR ALL ITEMS FROM AN EXHIBIT BOOTH.**

LIMITATION OF LIABILITY: It is expressly understood and agreed that by leasing sales space in the 19WOC Show, the exhibitor agrees that he will make no claim of any kind against 19WOC or any of its members or employees for any loss, damage or destruction of goods, not for any injury that may occur to himself or his employees while in the exhibit area, nor for any damage of any nature or character whatsoever.

INDEMNIFICATION: The exhibitor further agrees to indemnify and hold harmless 19WOC successors and assigns against all loss, cost, expense, including attorney fees, claims, suits and judgments whatsoever in connection with injury to or death of any persons, loss or damage to any property, arising from or in any way connected with performance of the exhibitor, its personnel or equipment.

ITEMS NOT COVERED: All points not covered herein are subject to settlement by the general policies of the 19WOC. The 19WOC and the Show Committee reserves the right to make such changes, amendments and additions to these rules and such further regulation as they shall consider necessary for the benefit of the Show.

NON-COMPLIANCE TO RULES AND REGULATIONS: Each exhibitor and his employees agree to abide by the Rules and Regulations given herein and by subsequent amendments and additions considered by 19WOC and Show Committee to be in the best interest of all exhibitors. Upon non-compliance with the Rules formulated, 19WOC and the Show Committee reserved the right to prohibit, reject or eject any exhibitor, exhibitor representative, or exhibit, in whole or part, with or without giving cause. If cause is not given, liability shall not exceed the return to exhibiting company of rental unearned at times of ejection. If an exhibitor is ejected for violation of these rules, or for any other reason, with cause, no return of rental fee shall be made.

SHOW SCHEDULE: A show schedule will be provided to each exhibitor receiving display and/or sales mart space. This schedule will include rules and regulations pertaining to exhibits, entries, judging and award.
